

## Northern NDAA Compliance

Dear Northern Customer:

In order for Northern to address cybersecurity concerns raised by its customers, we are providing important product information certifying compliance with the John S. McCain National Defense Authorization Act (NDAA) for fiscal year 2019, signed into law on August 13, 2018.

Section 889 of the NDAA prohibits the use of federal funds to acquire telecommunications equipment manufactured by Huawei Technologies Company, ZTE Corporation, Hytera Communications Corporation, Hangzhou Hikvision Digital Technology Company or Dahua Technology Company (or any subsidiary or affiliate), or telecommunications of video surveillance services provided by such entities or using such equipment, for use in US Government deployments. More specifically, the Act states as follows:

- (a) Prohibition on Use or Procurement.--(1) The head of an executive agency may not--  
 (A) procure or obtain or extend or renew a contract to procure or obtain any equipment, system, or service that uses covered telecommunications equipment or services as a substantial or essential component of any system, or as critical technology as part of any system; (effective August 13, 2019)  
 or  
 (B) enter into a contract (or extend or renew a contract) with an entity that uses any equipment, system, or service that uses covered telecommunications equipment or services as a substantial or essential component of any system, or as critical technology as part of any system. (effective August 13, 2020)
