# 1 Appearance Description




Figure 1-1 Overview

Please make sure that the power adapter is compatible with the camera. This series of camera support Power over Ethernet (PoE), and the standard power is 12 VDC. Press RESET about 10s when the camera is powering on or rebooting to restore the default settings, including the user name, password, IP address, port No., etc.

## 2 Installation

---

### *Before you start:*

- Make sure the device in the package is in good condition and all the assembly parts are included.
- Make sure all the related equipment is power-off during the installation.
- Check the specification of the products for the installation environment.
- Make sure the power supply is matched with your required voltage to avoid damage.
- If the product does not function properly, please contact your dealer or the nearest service center. Do not disassemble the camera for repair or maintenance by yourself.
- Make sure that the wall is strong enough to withstand three times the weight of the camera.



For the camera that supports IR, you are required to pay attention to the following precautions to prevent IR reflection:

- Dust or grease on the dome cover will cause IR reflection. Please do not remove the dome cover film until the installation is finished. If there is dust or grease on the dome cover, clean the dome cover with clean soft cloth and isopropyl alcohol.

- Make sure that there is no reflective surface too close to the camera lens. The IR light from the camera may reflect back into the lens causing reflection.
- The foam ring around the lens must be seated flush against the inner surface of the bubble to isolate the lens from the IR LEDs. Fasten the dome cover to camera body so that the foam ring and the dome cover are attached seamlessly.

## 2.1 Ceiling Mounting

### Steps:

1. Drill the screw holes on the ceiling according to the drill template.




Figure 2-1 Drilling Template

2. Loosen the set screws with a hex key (supplied) to remove the bubble.




Figure 2-2 Remove the Bubble

3. Fix the mounting base on the ceiling with screws.




Figure 2-3 Fix the Mounting Base



If required, you can route cables through the side opening on the side of the mounting base.




Figure 2-4 Side Opening

4. Loosen the tilt lock screws, adjust the tilting position in a range of 65 degrees, and tighten the tilt lock screws.
5. For type I camera--Rotate the black liner to adjust the pan angle [0°~360°] and tilt angle [0°~65°].




Figure 2-5 Type I Camera Angle Adjustment



Type II camera supports 3-axis adjustment. Loosen the tilt adjust screw to adjust the tilt angle [0°~75°], hold the black liner to adjust the pan angle [0°~355°], and hold the lens to rotate the camera [0°~355°]. See figure below.




Figure 2-6 3-axis Adjustment of Type II Camera

- Reinstall the bubble and tighten the screws.




Figure 2-7 Bubble Reinstallation

## 2.2 Micro SD Card Installation

### Steps:

1. Loosen the lock screws on the bubble to disassemble the camera.




Figure 2-8 Disassemble the Camera

2. Insert the micro SD card to the card slot.
3. Push the inserted micro SD card inside, and the micro SD card will be sprung out.




Figure 2-9 Insert the Micro SD Card

4. Install the bubble back, and tighten the lock screws on it.




Figure 2-10 Install the Bubble

## Setting the Network Camera over the LAN

### Note:

### 2.3 Wiring

Please connect to the camera to the network according to the following figures




Figure 2-11 Connecting Directly




Figure 2-12 Connecting via a Switch or a Router

### 2.4 Activating the Camera

You are required to activate the camera first by setting a strong password for it before you can use the camera.

Activation via Web Browser, Activation via SADP, and Activation via Client Software are all supported. We take activation via SADP software and Activation via Web Browser as examples to introduce the camera activation. Please refer to the User Manual of Network Camera for Activation via Client Software.

#### 2.4.1 Activation via Web Browser

##### **Steps:**

1. Power on the camera, and connect the camera to the network.
2. Input the IP address into the address bar of the web browser, and click Enter to enter the activation interface.

##### **Notes:**

- The default IP address of the camera is 192.168.1.64.




Figure 2-13 Activation Interface(Web)

3. Create a password and input the password into the password field.



**STRONG PASSWORD RECOMMENDED**— *We highly recommend you create a strong password of your own choosing (using a minimum of 8 characters, including upper case letters, lower case letters, numbers, and special characters) in order to increase the security of your product. And we recommend you reset your password regularly, especially in the high security system, resetting the password monthly or weekly can better protect your product.*

4. Confirm the password.
5. Click **OK** to save the password and enter the live view interface.

### 2.4.2 Activation via SADP Software

SADP software is used for detecting the online device, activating the camera, and resetting the password.

Get the SADP software from the supplied disk or the official website, and install the SADP according to the prompts. Follow the steps to activate the camera, please refer to the User Manual of Network Camera for other two activation methods.

#### **Steps:**

1. Run the SADP software to search the online devices.
2. Check the device status from the device list, and select the inactive device.





**STRONG PASSWORD RECOMMENDED**– *We highly recommend you create a strong password of your own choosing (using a minimum of 8 characters, including upper case letters, lower case letters, numbers, and special characters) in order to increase the security of your product. And we recommend you reset your password regularly, especially in the high security system, resetting the password monthly or weekly can better protect your product.*

4. Click **OK** to save the password.

You can check whether the activation is completed on the popup window. If activation failed, please make sure that the password meets the requirement and try again.

## 2.5 Modifying the IP Address

### ***Purpose:***

To view and configure the camera via LAN (Local Area Network), you need to connect the network camera in the same subnet with your PC. Then, install the SADP software or client software to search and change the IP of network camera. We will take modifying the IP Address via SADP software as an example to introduce the IP address modification.

### ***Steps:***

1. Run the SADP software.
2. Select an activate device.

**Note:**

Please refer to Chapter 3.2 to activate the camera if the camera is inactive.

3. Change the device IP address to the same subnet with your computer by either modifying the IP address manually or checking the checkbox of Enable DHCP.

4. Input the password to activate your IP address modification.  
The batch IP address modification is supported by the SADP. Please refer to the User Manual of SADP for details.

## 3 Accessing via Web Browser

---

### **System Requirement:**

Operating System: Microsoft Windows XP SP1 and above version

CPU: 2.0 GHz or higher

RAM: 1G or higher

Display: 1024×768 resolution or higher

Web Browser: Internet Explorer 8.0 and above version, Apple Safari 5.0.2 and above version, Mozilla Firefox 5.0 and above version and Google Chrome 18 and above version

### **Steps:**

1. Open the web browser.
2. In the browser address bar, input the IP address of the network camera, and press the **Enter** key to enter the login interface.

#### **Note:**

- The default IP address is 192.168.1.64.
  - If the camera is not activated, please activate the camera first according to Chapter 3.2.
3. Input the user name and password.

The admin user should configure the device accounts and user/operator permissions properly. Delete the unnecessary accounts and user/operator permissions.

#### **Note:**

The device IP address gets locked if the admin user performs 7 failed password attempts (5 attempts for the user/operator).

4. Click **Login**.




Figure 3-1 Login Interface

5. Install the plug-in before viewing the live video and managing the camera. Please follow the installation prompts to install the plug-in.



You may have to close the web browser to finish the installation of the plug-in.




Figure 3-2 Download Plug-in
